Patient Questionnaires	Members were given a copy of the results of the IPQ Patient Questionnaires. A discussion took place to identify areas of concern and ideas discussed to bring about improvements in these areas. Ideas discussed and points raised:- Possibility of shorter appointments being available to patients. A doctor to triage appointments on the day, plus other duties in between. Gents toilets need to be refurbished and kept cleaner. Pictures and plants in the waiting room would improve the overall look of the waiting area. Doctors to step further into the waiting room when calling patients names out so they can be clearly heard. A static plastic toy station that can be wiped down to be provided to entertain young children in the waiting room. Create separate queues for patients waiting to speak to reception and the chemist. Display photographs and names of doctors and nurses in the waiting area so that patients are aware of whom they have an appointment with. Promote the availability of telephone consultations. Encourage more people to self check in, if a doctor is delayed see if this can be displayed on the check in screen once patient has checked in. Receptionists to encourage patients no to queue at reception to hand a prescription in, but to place in the prescription box on the next occasion.	ALL
